# **Proof of Attendance Forms**

Within 30 days of the show ending, attendees will receive an email with instructions on how to access their proof of attendance forms for all sessions where their badge was scanned prior to entrance. Once received, NCNLA encourages all attendees to confirm their attendance is recorded correctly.

The information provided below was extracted from the corresponding licensing boards' websites, for current licensing requirements, please contact your licensing board.

## **NC Landscape Contractors**

- All licensed landscape contractors must personally complete seven (7) hours of Board Approved Continuing Education per year. Three (3) of seven (7) CE credits must be "landscape (technical)" credits and two (2) of seven (7) must be "business" credits. The remaining two (2) may be either landscape or business.

## **NC Irrigation Contractors**

- Licensees are required to earn ten (10) continuing education credits each year, six (6) irrigation and four (4) business.

## **NC Landscape Architects**

- In order for a licensee to qualify for license renewal as a Landscape Architect in North Carolina, the licensee must have completed ten (10) contact hours of approved continuing education within the previous renewal period.
- Please note: Sessions submitted to NCBOLA for review are 50-minutes in length and if approved, qualify for 0.83 hours.
